China Council for International Cooperation on Environment and Development and BRI International Green Development Coalition Roundtable Meeting on Collaborative Governance on Climate and the UN 2030 Agenda for Sustainable Development was held in New York, the United States

The China Council for International Cooperation on Environment and Development (CCICED) and BRI International Green Development Coalition (BRIGC) Roundtable Meeting on Collaborative Governance on Climate and the UN 2030 Agenda for Sustainable Development was held in New York City, U. S. on September 24, 2019 during the peripheral of the United Nations Climate Action Summit. The Meeting was co-organized by CCICED Secretariat and the BRIGC Secretariat, in collaboration with the Environmental Defense Fund (EDF), World Resource Institute (WRI), and World Wide Fund for Nation (WWF). The discussions were structured in two sessions, with focuses on priority areas for global collaborative governance on climate and the initiatives for global development cooperation and 2030 Agenda for Sustainable Development respectively. Over 100 participants attended the Meeting, including International Chief Advisor of CCICED, CCICED Members and Special Advisors, Co-chairs of BRIGC, BRIGC Advisors, Partners and experts.

The delegates shared experience and practices on collaborative governance and noted the importance to strengthen policy and institutional innovation, to make good use of existing platforms, and to promote stakeholder cooperation, so as to make greater contributions to the successful implementation of 2030 Agenda for Sustainable Development.

Here is a summary for the Roundtable Meeting and the remarks from the floor:

Session 1: Priority Areas for Global Collaborative Governance on Climate

The Session 1 was chaired by Mr. Andrew Steer, CCICED Member, Co-Chair of BRIGC, President and CEO of World Resources Institute. Mr. Xie Zhenhua, CCICED Vice Chairperson and Special Envoy for Climate Affairs of China, delivered opening remarks. Ms. Kate Hampton, International Team Leader of CCICED SPS on Global Climate Governance and China's Role, Advisor of the Advisory Committee of BRIGC, CEO of Children's Investment Fund Foundation; and Mr. Marco Lambertini, CCICED Member, Co-chair of BRIGC, Director General of WWF International, made leading remarks. Delegates shared the achievements and measures on collaborative governance of mitigation and adaptation of climate change, as well as air quality improvement and biodiversity conservation.

Highlights of the Remarks



China is committed to combating climate change while conserving the ecological environment, and explores a green low-carbon development path that coordinates climate change mitigation and adaptation, economic development and eco-environmental protection. The practices can be a source of reference to be disseminated and replicated in other countries of the world. As for strengthening global collaborative governance on climate in the future, there are three suggestions: firstly, to fully recognize the consistency between combating climate change and promoting high-quality development, and coordinate environmental protection, climate change mitigation and adaptation, as well as socio-economic development; secondly, to call for enhanced cooperation and concerted efforts from the international community in implementing the emission reduction commitments in the Paris Agreement and achieving 2030 Agenda for Sustainable Development; thirdly, to actively boost innovation, making full use of the available innovative mechanisms such as CCICED and BRIGC to provide new thinking and proposals for implementing the 2030 Agenda for Sustainable Development and improving the global environmental governance system.

The concept of a community of shared future for mankind, the Belt and Road Initiative and the $14^{\rm th}$ Five-Year Plan proposed by China provide huge opportunities for green and low-carbon development on a global level. The world needs China to demonstrate leadership in climate governance. It is necessary for Europe and China to enhance in-depth cooperation in green finance to add impetus to the realization of sustainable development worldwide and more ambitious climate goals.

The world today is faced with the dual challenge of climate change and biodiversity degradation. Biodiversity conservation and addressing climate change are interrelated and complementary. The year 2020 is a key opportunity that should be seized by countries around the world to translate their commitments in addressing climate change and conserving biodiversity into concrete actions. It is crucial to set up clear, measurable and ambitious targets and adopt nature-based solutions to protect forests, wetlands and marine resources.

There is basically zero investment in fossil fuel and a constantly growing share in renewable energy, creating both environmental and economic benefits. Currently, the investment in renewable energy has reached 11 trillion USD on a global level.



Session 2: Initiatives for Global Development Cooperation and 2030 Agenda for Sustainable Development

The Session 2 was chaired by Mr. Vidar Helgesen, CCICED Vice Chairperson, Co-Chair of BRIGC, Norway's Special Envoy to the High-level Panel on Building a Sustainable Ocean Economy, and leading remarks were made by Mr. Erik Solheim, CCICED Vice Chairperson, Convener of Advisory Committee of BRIGC, Advisor of WRI, and Mr. Scott Vaughan, International Chief Advisor of CCICED. The participants discussed the green path for 2030 Agenda for Sustainable Development, especially its relationship with key international public products such as BRI.

Highlights of the Remarks



Mr. Erik Solheim, CCICED Vice Chairperson, Convener of Advisory Committee of BRIGC, Advisor of WRI

As green BRI and 2030 Agenda for Sustainable Development are highly consistent in terms of concepts, principles and goals, there is an obvious synergy between them. We should encourage more private enterprises to take part in the green BRI cooperation, enabling it to play a greater leading role.

BRIGC's flagship research product – the Green BRI Annual Report would be designed to assess the regional environmental risks as well as the environmental quality improvement measures and potential, so as to lay the foundation for a targeted green development plan.

The world today is faced with great uncertainties, and the multi-lateral trading system is under pressure. Practices on transiting towards a green economy such as promoting circular trades and green supply chains will provide solutions.

Both the BRI and South-South cooperation are the important approaches toward Sustainable Development. Efforts should be made to strengthen their linkage, cross-reference, and alignment to create synergies and co-benefits. Enhanced effort is needed to promote the green Belt and Road strategy under the framework of South-South cooperation to make it a model for South-South cooperation between China and the rest developing countries. Existing major activities for green BRI development include BRIGC Thematic Partnership on South-South Environmental Cooperation and SGDs Capacity Building, Green Envoys Program for Silk Road, the Belt and Road South-South Cooperation Initiative on Climate Change, as well as the Belt and Road Environmental Technology Exchange and Transfer Center (Shenzhen).

Most of the countries along the Belt and Road are developing countries. BRI can create an infrastructure investment market as large as 1.5 trillion USD per year, and China has world-leading standards in the fields of automobile and building materials, which are great opportunities for Chinese enterprises and investment destinations to realize green development. China should increase efforts in promoting green cooperation and low carbon development of energy-intensive industries within the Belt & Road countries.



Green BRI has various development opportunities concerning the ocean, green energies, biodiversity, etc. Firstly, we need to advance development in priority areas for global collaborative governance on climate such as biodiversity conservation, environmental quality improvement, green investment and green energy. Secondly, we need to promote nature-based solutions and conduct studies on the economic benefits of protecting the eco-environment. Thirdly, we need to make the best use of green BRI and the BRIGC's platform, so as to realize 2030 Agenda for Sustainable Development.


